Subject: IMPORTANT: 2018-2019 Benefit Plan Information, Benefits Meeting Schedule, and Rates

For the upcoming 2018-2019 Plan Year, coverage options for Montana University System (MUS) retirees include enrollment in the MUS *Choices* options for both non-Medicare and Medicare retirees. The annual enrollment dates for MUS retirees to make benefit changes will be from April 11-May 18, 2018.

We encourage you to plan to attend one of the upcoming 2018 MUS *Choices* Retiree Benefits meetings presented by the MUS Employee Benefits office at a location near you to learn more about your benefit plan options for the upcoming plan year. If a benefits meeting is not being held by the MUS Employee Benefits office at a location near you, the benefits presentation will be available for viewing live online on the *Choices* website at www.choices.mus.edu on April 10th from 2:00-3:30pm via WebEx. The recorded WebEx benefits presentation will be available on the *Choices* website to view beginning April 12th at your convenience. You may also check with your campus Human Resources/Benefits office to see if they will be offering a retiree benefits presentation.

The Retiree *Choices* benefit booklets will be mailed to retirees during the week of April 16, 2018. The retiree benefit booklet, as well as the benefits slide presentation, will be available online on the *Choices* website at www.choices.mus.edu.

For the 2018-2019 Plan Year, the MUS *Choices* Retiree Benefit Plan has some medical benefit changes in the form of increases to in-network deductibles, in-network coinsurance percentage, and out-of-pocket maximums, as well as office visit copayments. These benefit changes are necessary to minimize premium increases and to ensure the MUS Benefit Plan remains financially healthy.

Beginning July 1, 2018, the following medical benefit adjustments will be implemented:

Benefit changes alone are not sufficient to maintain Plan financial stability; therefore, it is also necessary for the Plan to make premium rate adjustments for the 2018-2019 Plan Year by removing the subsidies previously provided to dependents.

Below are charts indicating the monthly medical, dental, and vison hardware rates, as of July 1, 2018, for your coverage under the MUS *Choices* Retiree Benefit Plan, which will vary depending on which plan(s) you select and whether you cover dependents:

If you choose to disenroll from the MUS *Choices* Retiree Benefit Plan effective July 1, 2018, you must notify your MUS campus Human Resources/Benefits office no later than Friday, May 18, 2018. If you disenroll from the Plan, you will not be able to return to the Plan in the future.

What do you need to do?

- (1) Plan to attend a 2018 MUS Retiree Benefits meeting.
- (2) If you are making benefit changes for the 2018-2019 Plan Year to your MUS *Choices* Retiree Benefit Plan, you must submit your enrollment form to your campus Human Resources/Benefits office by **Friday, May 18, 2018**.
- (3) If you do not want to make any changes to your current MUS *Choices* Retiree Benefit Plan, you **do not** need to submit an enrollment form and you will be automatically enrolled in your current benefits.
- (4) If you choose to disenroll from the MUS *Choices* Retiree Benefit Plan, you must notify your MUS campus Human Resources/Benefits office no later than **Friday**, **May 18, 2018**.
