Montana University System Benefit Plan Retiree Members <a href="IMPORTANT">IMPORTANT</a>: 2025 Annual Enrollment Benefit Plan and Premium Changes

The Montana University System *Choices* Benefit Plan (MUS Plan) is your self-insured employer sponsored plan covering over 16,000 MUS employees, retirees, COBRA enrollees and family members. The MUS Plan, funded by a combination of contributions as determined by the Montana Legislature and Plan member premiums, is responsible for providing health care coverage for you and your family members in accordance with state and federal laws.

During 2024, the MUS Plan saw a significant increase in health care costs and utilization. These increases are driving necessary benefit changes and premium increases. Beginning July 1, 2025, the MUS Plan will implement medical benefit adjustments and dental premium increases. Additionally, there will be increases to the diagnostic and preventive dental fee schedule amounts.

Retiree **Select Plan** dental premium changes are as follows:

The 2025-2026 MUS Choices Annual Enrollment period will be from April 24 - May 15, 2025.

## What do you need to do?

- (1) If you are making benefit changes to your MUS Plan coverages for the 2025-2026 Plan Year, you must submit a hardcopy retiree enrollment form to your campus Benefits Representative by 5:00 p.m. (MST) on Thursday, May 15, 2025. If you disenroll from the Plan, you will not be able to return to the Plan in the future.
- (2) If you do not want to make any changes to your current MUS Plan coverages, you **do not** need to submit a retiree enrollment form and will **automatically** be re-enrolled in your current benefits.
